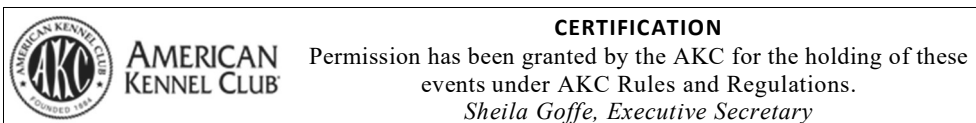

Jump Height is required for all classes with jumps.
Classes with jumps will run in ascending jump height order,
beginning with the lowest jump in all trials. Exceptions to jump height running
order may be made for handlers with multiple entries.
Rally Trials will run consecutively.

Judges are not required to wait for dogs. It is the responsibility of the owner or
handler to have the dog at ringside when its class is called.

Transfers will be allowed after closing,
except in the case of ineligibility as per AKC rules and regulations.

Refund for bitches in season (less administrative fee) with veterinarian's note.

All dogs present must be on leash or confined to a crate except when being
judged in the ring.

Crating space will be available on a limited basis. The trial site requires a tarp to
be placed on the floor underneath your crates.
